Grant award must be used for project requested. **Those awarded a grant must provide written proof of its use within six (6) months of award.**

To apply for a 2008 Dayton and Miami Valley Community Investment Grant, please complete the attached application form, provide the following requirements, and return the application packet to Think^{TV} no later than May 1st, 2008. Grant checks will be awarded on November 1st, 2008 and the recipients will be recognized at the Speaking of Women's Health conference at the Dayton Convention Center on November 1st, 2008.

All information must be turned in as a packet to be considered for funding. Only requests \$2,000.00 and under will be considered.

- 1. Requesting organization must be physically located in Dayton, Ohio**
- 2. Complete the enclosed application form**
- 3. Provide verification of 501 (c)(3) status.**
- 4. Provide a list of board members**
- 5. Provide a copy of the organization's mission statement or bio**
- 6. Provide 3 reasons WHY it is important to support your program**
- 7. Provide 3 reason HOW your program enhances the lives of women**
- 8. Give a brief explanation of how the Speaking of Women's Health Community Investment Grant would be used.**
- 9. Provide an approximate number of the people who will be reached through your program.**
- 10. Provide any additional information that may be deemed as relevant**
- 11. Provide other sponsorship requests to fund your project if partial request is funded.**

**** If all items required are not provided, application will be disqualified**.**
